
Formatting (Design) Rules for the Articles of the Scientific Journal of RTU Research Centre for Engineering History (RCEH)

«History of Engineering Sciences and Institutions of Higher Education»

• The article must be submitted in MS Word format, not exceeding **5000** words (~10–12 pages), appending summaries in English (at the beginning of the scientific article) and Latvian (at the end of the scientific article) (each summary is **120–150** words) with 3–5 key words (concepts) and a short biography of the author with a maximum of **150** words, obligatorily indicating contacts (address, e-mail, telephone).

1. Page layout

Top: 2 cm; bottom: 2 cm; right: 2 cm; left: 3 cm



2. Text formatting (design)

Line spacing (before -0, after -0)



Paragraph: 1.5 points



Font: Times New Roman




Font size: 12 points



Alignment: justify (for whole text; titles, images, tables, etc. c. names do not need to be centred)



Quotation marks used in the text: «»



The dash used in the text: long – (not hyphen: -)

Hyphen (if one concept is denoted by several words) not equal to dash: for example, Vaira Vīķe-Freiberga, bench-gel coating.

Title (under it – name, surname and representation of the authors):

Title: bold, 12 points

Name, Surname: Caps Lock, bold, 12 points

Representation: 12 points, regular

Do not put a dot (full stop) after the headings and subheadings!

Slash use:

- if the concept is denoted by the same word on both sides of the slash, the space before and after the slash need not be used: director/rector;
- if the concept is denoted by several words on both sides, the space before and after the slash must be used: Riga Polytechnicum / Riga Polytechnic Institute.

Decimal writing (with meaning from-to): 1910–1912.

Notes and explanations should be footnoted when selecting References – Footnote.



3. Image formatting (design)

The image is placed in the text and numbered sequentially.

Ilze Gudro (see Figure 1) is the Director of the RTU Research Centre for Engineering History. If the image is on another page, it must be specified (see Figure 1, p. x).

The dot (full stop) behind the captions of the pictures is put; including date.

Image references are placed under the section «Sources of Illustrations» and are numbered separately from the text references.

Images used in the text should be sent in a common file named figure_1, figure_2 – as they are used sequentially in the article. Image resolution: 300 dpi or size 5 mb. The picture must be clear, without fog.

4. Table formatting (design)

The table is placed in the text next to a specific reference, numbered consecutively. If the table is on another page, this must be indicated (see Table 1, p. xx).

There is no dot (full stop) behind the table captions!

5. Reference formatting (design)

References in the literature and illustrations are numbered in the order in which they are used, starting with the first, in square brackets -[1], if several sources are used, indicate this -[1, 2, 3]. If the pages used must be indicated [1; p. 2].

Also in the «References» and «Sources of Illustrations» sections, the reference number is given in square brackets.

The pages used shall be indicated for the literature source.

Surname, N.. *Title*. Place of publishing: Publisher, 2008, pp. 86 (total volume); p. 5 (page used in article).

If archival materials are repeated, abbreviations should be used
